DAVID ROCKEFELLER

Financier, founder of the Downtown-Lower Manhattan Association that chiefly advanced construction of the World Trade Center complex, former CEO of the Chase Manhattan Bank, former Chairman of the Council on Foreign Relations



RALPH EBERHARDT

U.S. Air Force General, head of North American Air Defense (NORAD) on 9/11/01. current military chief of the Northern Command over the U.S., Canada and Mexico



LARRY SILVERSTEIN

Developer of the 47-story World Trade Center Building 7 (completed 1986, demolished 9/11/01); lease-holder of the WTC Twin Towers and Buildings 4 and 5 as of 7/26/01; admitted executor of WTC Building 7 demolition.

DICK CHENEY

Overseer on 9/11/01 of FEMA’s Office of National Preparedness, former U.S. Secretary of Defense, former CEO of the Halliburton Corporation, current U.S. Vice-President



PETER G. PETERSON

Financier, Chairman of the mortgage-holding Blackstone Group, current Chairman of the C. F. R.



RUDOLPH GIULIANI

Former Mayor of New York City; promoter of City’s Emergency Command Center on 23rd Floor of WTC Building 7 (completed 1997. demolished 2001); failed to inform firefighters of forewarning that the South Tower was “gonna collapse” on 9/11/01



DONALD RUMSFELD

former CEO of the G.D. Searle corporation (pharmaceuticals) former and current U.S. Secretary of Defense, former friendly envoy from the U.S. to Saddam Hussein, incommunicado during hijacking of airliners on 9/11/01



MONTAGUE WINFIELD

former Brigadier General, left post as Deputy Director of the Pentagon’s National Military Command Center on 9/11/01; current Major General

JOE ALLBAUGH

Director of the Federal Emergency Management Agency (FEMA) on 9/11/01; former campaign manager of candidate for Governor and President George W. Bush

Reporter, New York Times
